

# Swyve – Terms of Service

---

Effective Date: 20<sup>th</sup> October 2025

## Welcome

Welcome to Swyve, a short-form video platform for adults. These Terms of Service ("Terms") are a legal agreement between you and Swyve LTD ("we", "us", "our") and govern your use of Swyve.io (the "Platform"). Please read them carefully. By using Swyve, you agree to be bound by these Terms.

## 1. Who Can Use Swyve

You may only use Swyve if:

- You are at least 18 years old
- The country or state you are in does not prohibit adult content
- You successfully complete our identity verification process if you wish to upload or monetize content

If any of these do not apply to you, do not use Swyve.

## 2. Your Responsibilities

You agree to:

- Follow the law and respect other people's rights
- Only post content you have the right to post, including necessary consent from anyone appearing in it
- Not upload illegal or prohibited content (e.g., minors, non-consensual acts, hate speech, violence)
- Not impersonate anyone or misrepresent yourself

You are fully responsible for your content and your actions on the platform.

## 3. Verification & Uploading

To upload adult content, you must:

- Verify your identity with valid government-issued ID
- Confirm that everyone appearing in your content is 18+ and has given permission
- Keep age verification and consent records as required by law

We reserve the right to reject or remove content or accounts at any time, for any reason.

## 4. Monetization & Payouts

If you participate in our monetization program:

- You will receive a percentage of ad revenue from your content
- Minimum payout threshold: \$100 USD
- You are responsible for your own taxes and must provide correct payment info

We may withhold or cancel payments if you violate these Terms.

## 5. Content Reporting & Moderation

### -Pre-Screening of All User-Uploaded Content

Before any user-uploaded content is made publicly available on Swyve, it is reviewed manually by our internal moderation team. Our moderators check every piece of content to ensure it does not contain minors, illegal activities, non-consensual acts, trafficking, or any other violations of our policies or applicable laws. Content will only be published once it has been approved by our team. Any content that fails pre-screening will be rejected or removed.

You can report content that you believe:

- Violates the law or our policies
- Involves abuse, minors, or non-consensual acts

We may:

- Issue warnings
- Restrict or remove content
- Suspend or ban accounts
- Report to law enforcement where required

## 6. Appeals and Content Removal Policy

Any person depicted in content on Swyve has the right to request removal of that content at any time. To request removal, the individual must email [swyve@swyve.io](mailto:swyve@swyve.io) and provide a link to the content and proof of identity.

Once a request is received, Swyve will temporarily disable or remove the content while our moderation team reviews the appeal. All appeals will be reviewed and resolved within five (5) business days.

Content will be permanently removed if consent was not provided, consent has been withdrawn, the person has a legal right to removal, or the content violates Swyve's policies or any applicable law.

If the creator disputes the removal request, Swyve will not reinstate the content until the matter is resolved. In cases of disagreement, Swyve allows resolution by a neutral third party, in accordance with industry and payment processor requirements.

Uploading non-consensual content or failing to comply with consent obligations may result in account suspension or termination.

## **7. Licensing and Use of Content**

By uploading content to Swyve, you grant us a worldwide, non-exclusive, royalty-free license to:

- Display and distribute your content on our platform
- Promote Swyve using your content

You retain full ownership of your content.

## **8. Intellectual Property**

You may not:

- Copy or distribute content from Swyve without permission
- Use our branding or platform for illegal or misleading purposes

We respect copyright and will respond to takedown notices.

## **9. Account Security**

You're responsible for:

- Keeping your login information secure
- Not sharing your account with others
- Not using others' accounts

## **10. Jurisdiction & Legal Terms**

- These Terms are governed by the laws of Cyprus
- Any disputes will be resolved in the courts of Cyprus
- You agree to binding arbitration if required in your country

We may change these Terms. Continued use after changes means you accept them.

## **11. Disclaimer & Limitation of Liability**

We provide Swyve "as is". We do not guarantee:

- That the platform will always be available or error-free
- That content will be accurate or suitable for you

We're not liable for:

- Loss of data or earnings
- User content
- Third-party services or actions
